Disqualification

Evidence of lameness; fall to the ground by horse; improper equipment; exhibitor disrespect to judge; blatant striking of horse to cause forward or lateral movement with the longe whip; horse steps over or becomes entangled in the longe line; failure to show at all three gaits in both directions; horse becomes loose in the arena.
